



Gift Agreement Between the Autonomous University of Baja California and The University of California Riverside Foundation

To establish the Autonomous University of Baja California - UC Riverside Mechanical Engineering International Student Exchange Fund

I. INTRODUCTION

The Autonomous University of Baja California (UABC) ["Donor"] wishes to establish a current restricted fund with the UC Riverside Foundation ["Foundation"] to benefit the University of California, Riverside campus, and is pleased to pledge USD \$50,000 to the Foundation. The fund shall be known as the UABC-UCR Mechanical Engineering International Student Exchange Fund ("Fund") and will provide current support for undergraduate engineering students from UABC who wish to participate in summer programs with the Department of Mechanical Engineering in the Bourns College of Engineering at the University of California, Riverside (UCR).

BACKGROUND

Founded in 1957, the Autonomous University of Baja California is the fruit of several generations of Baja Californians' continuing efforts. In the course of its development it has undergone many changes, determined by the institution's responsibility toward the citizens of its home state, in the improvement of whose lives it plays a major role.

Conscious of the vast changes taking place in contemporary society, UABC recognizes the immense importance of making itself a learning community in which innovation, constant improvement, equal opportunity and transparency must continually characterize it as the state's leading educational institution.

Although the UABC is a public institution, it is not administered by the state government, but has the complete legal authority to carry out its crucial functions: teaching, research, cultural diffusion and community service.

The Bourns College of Engineering at UC Riverside is dedicated to educating the next generation of engineering leaders to discover and apply groundbreaking solutions and innovations that improve the quality of life. Since the college was launched 25 years ago, it has distinguished itself through faculty leadership in research and teaching, partnerships with industry and government, engagement with local and global communities, remarkable growth, and top-tier rankings. The college prides itself on providing opportunities for close student-faculty collaboration both in the classroom and in the laboratory.



II. ESTABLISHMENT OF FUND

This fund shall be established when:

- A. This memo has been reviewed, signed and dated by the Donor and appropriate university officials and has been fully funded.
- B. This irrevocable pledge is to be paid prior to June 15th, 2014. Additions to the Fund can be made at any time.

III. PURPOSE AND USE OF CURRENT RESTRICTED FUND

The UABC-UCR Mechanical Engineering International Student Fund provides resources to help cover the costs of undergraduate students from UABC who want to spend a summer at the University of California, Riverside, gaining valuable experience in mechanical engineering as well as in learning about another culture. The program prepares students from Mexico and the U.S. to work on international team projects and provides both sides with insights into other countries, cultures and institutional backgrounds. Goals of the collaboration include:

- To foster a deeper understanding in undergraduate engineering students of the culture, language and business practices of another country, and to communicate shared interests and objectives in the course of collaborative team projects and research.
- To benefit society by promoting international cooperation and partnerships to address the challenges of the global community.

The UABC-UCR Mechanical Engineering International Student Exchange Fund will provide support for the Mechanical Engineering Department at UCR, under the direction of the Dean and in consultation with the Chair of the Mechanical Engineering Department. This gift will help support the exchange program with international students from the UABC who visit UCR during the summer. Costs include items such as student housing in UCR's International Village, meals, educational supplies, GRE classes and weekly workshops, academic events and activities, plus a mentor research allowance to assist with supplies, consumables, social activities, and expenses associated with the paperwork needed for these students to request their J1 visas at the US consulate.

IV. Administrative and Gift Service Fees

As is customary with universities and other non-profit organizations across the United States, a one-time gift fee is applied to each pledge payment in order to provide essential support to UCR's advancement program. We understand that the fee is currently 5%.

Letter of Understanding Between the Autonomous University of Baja California and The University of California Riverside Foundation

The University of California, Riverside (UCR) is pleased to establish a student exchange program with the Autonomous University of Baja California (UABC). Since it is our intention for this to be an ongoing program, the 2014 Gift Agreement provides a framework for a flexible program that will allow details to vary from year to year. This letter provides a few details concerning the 2014 summer program:

- 1. For the summer of 2014, UCR will accept 12 students from UABC who will study at UCR in the Bourns College of Engineering Mechanical Engineering Department.
- 2. The period of the program will be from June 23, 2014, to August 15, 2014.
- 3. UABC students will pay the following additional fees:
 - Student and Exchange Visitor Program Fee (EVIS). To participate in this program,
 each student must register in EVIS prior to his/her visit. The fee is \$180.00 USD.
 - b. International Student Insurance cost varies depending on the company, approximately \$170.00 USD.


